Tax Payment Information

Payments can be made:

- In Person at Village Hall – 7650 N Pheasant Lane, River Hills WI 53217
 Monday – Friday, 8:30 a.m. – 12:00 p.m. and 1:00 p.m. – 4:30 p.m.
- By mail
- By drop box after hours in the slot in the front door of Village Hall
- Make checks payable to: Treasurer – Village of River Hills

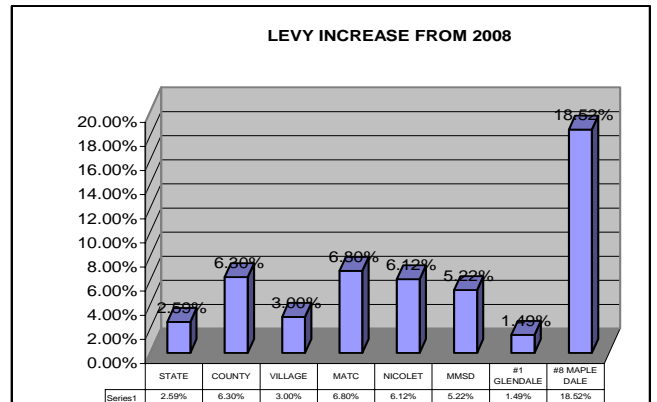
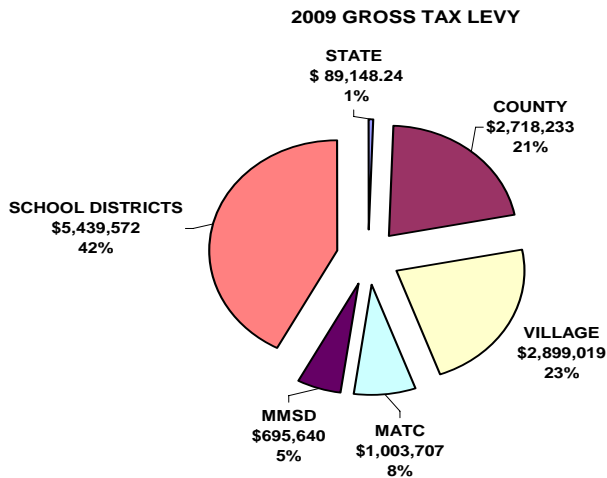
If you mail in your payment or leave it in the drop box, a receipt will be mailed back to you. Self addressed, stamped envelopes are encouraged. If you are paying with an escrow check made out to both you and the Village, please remember to endorse the back of the check. If the check is issued to two taxpayers whose names are separated by "and" both/all taxpayers must endorse the check. Refunds for overpayments will be processed within 20 days.

Payment options for tax bills are as follows:

(We DO NOT accept credit cards for tax payments):

➤ **Option 1 – Full Payment Option**

Full payment of real estate taxes plus special assessments, special charges and delinquent utility amounts, if any, are due on or before **January 31, 2010**.

➤ **Option 2 – Installment Option (No Reminder Statements Will Be Mailed)**

First Installment – January 31, 2010 - 50% of taxes plus all special assessments, charges and utility amounts due on or before January 31, 2010

Second Installment – March 31, 2010 – 25% of taxes are due on or before March 31, 2010

Third Installment – May 31, 2010 – 25% of taxes are due on or before March 31, 2010

For a payment to be considered timely, it must be received or postmarked on or before the due dates indicated above.

Other payments require a separate check:

If you are making other payments to the Village, such as sewer user bills, dog licenses, job orders, or other items, you will need to issue a separate check for these items. Please do not include them in the check with your tax payment.

2010 Pet Licenses:

2010 dog and cat licenses can be purchased online at www.madacc.com.

They can also be purchased at Village Hall.

Please bring proof of your pet's current rabies immunization.

Cost:

Dogs – Altered \$12, Unaltered \$24

Cats – Altered \$10, Unaltered \$20

Lottery & Gaming Credit (Located in the middle of your tax bill)

If you did not receive a Lottery & Gaming Credit on this tax bill and you are eligible (see requirements below), you have until **January 31, 2010** to file an application with this office. Applications are available at Village Hall and you may request one by calling the office at (414)352-8213 or stopping in to complete the application.

Eligibility requirements:

- 1) You must have been the owner of this property on January 1, 2009 and you must have used this property as your primary residence. You can only have one primary residence.
- 2) If you purchased the home after the January 1, 2009 date and you can certify the property was used by the previous owner as a primary residence on January 1, 2009 and it is also your primary residence, you can claim the lottery credit for the 2009 tax bill.

2010 Election Dates

(All elections are held on Tuesdays)

February 16, 2010 – Spring Primary – (only if needed)

April 6, 2010 – Spring Election

September 14, 2010 – Partisan Primary

November 2, 2010 – Fall General Election

2010 U.S. CENSUS
