FEE SCHEDULE

- A. **Minimum permit fee for all permits.....\$50.00**
- B. Heating & Incinerator Units \$50.00/unit, up to & including 150,000 input BTU units. Additional fee of \$16.00/ each 50,000 BTU or fraction thereof.
- C. Commercial/Industrial exhaust hoods..... \$110.00/ unit and exhaust systems
- D. Heating & Air Conditioning..... \$1.60/ 100 sq. ft. of Distribution Systems conditioned area with \$50.00 minimum
- E. Air Conditioning - other than wall units..... \$50.00/unit up to 3 tons or 36,000 BTU's. Additional fee of \$16.00/each ton or 12,000 BTU's or fraction thereof
- F. **Administrative Fee each permit.....\$10.00**

NOTE: A COPY OF YOUR CURRENT HVAC CREDENTIAL CARD, ISSUED BY THE WISCONSIN DEPARTMENT OF COMMERCE, MUST BE ON FILE AT THE VILLAGE HALL BEFORE A HEATING/ AIR CONDITIONING PERMIT WILL BE ISSUED.
